Participation

- Each participant is required to be present throughout the whole duration of the event, from the day of arrival until the day of departure, specified in the programme in bulletin.
- Each participant is obliged to take part in all of the non-sport activities.
- Each team undertakes to compete against all other participating teams.
- Each participant undertakes to compete against all other participants.
- The absence of any member of a participating team from any part of the entire sport programme, opening, prize-giving-, and closing ceremonies and socio-cultural programme may result in the disqualification of that team.

Arrivals

The official port of entry is:

-Foz do Iguaçu International Airport

The delegation will be welcomed at the airport terminal with the following ISF sign by volunteers : Delegations arriving at the airport will be taken directly to the accreditation center (CID) to obtain their accreditation. After their accreditation, they will be directed to their hotel rooms



48 hours before departure, all the delegation, need to confirm their departure information to the LOC. Delegation who need a negative covid test to take their flight or train, will be tested in their accomodation. Delegation need to inform LOC about needs for covid testing 48 hours before departure. The test will be at their own charges. They must pay in advance. Transportation will be organise to bring all the delegation to the official ports.

Event Disicplinary Commission

In accordance with the ISF General Competition Rules, The ISF Event Disciplinary Commission shall deal with all incidents and all violations of the ISF Statutes, Sport Policy, ISF Handbook, Rules, and any other ISF document linked to the ISF events and broadly with misbehaviors not directly related to the sport technical regulation during an ISF event.

The Commission is composed of the ISF Delegate, the TC Chair and LOC Representative.

Appeal jury

The Appeal Jury shall deal with all protests of a technical sporting nature during the competition. The Appeal Jury is composed of the Memeber of the ISF Technical Commission , one member of the Local Organising Committee, the Head Field of Play Officials

Anti doping

ISF being a Wada code signatory is promoting clean sport as one of the main values applied during its events. Besides the tests than can take place accordingly to the age category and the tradition of relevant sports, ISF in cooperation with WADA is implementing a large educational programme to raise awareness on the danger of doping behaviours.

The cultural visits will take place on Cataratas do Iguaçu. RECOMMENDATIONS TO THE MEMBERS OF THE DELEGATION, REFEREES AND ORGANIZATION:

• All buses will be identified by Countries;

• All must be in uniform with the official t-shirt of the event;

• Upon arrival, buses will go straight to the Point of Viewof the Falls, where the first photo will be recorded and then routed to the Falls Trail. The second photo will be at the end of the Trail in devil's throat;

• Preferably use the stairs, where the concentration will be for the return shipment.

• It is expressly forbidden to leave any kind of recyclable and non-recyclable waste in the preservation environment;

• It is forbidden to feed the coatis and wild animals, leave bags and backpacks loose, open and do not touch the animals;

• Tennis, sunscreen, cap and carry spare clothes for change are recommended;

• Do not wear open footwear, such as slippers, rasteirinhas and the like;

- Avoid dispersion during the cultural tour;
- Adopt the principle of organization, obedience and respect.



The Nation Night encourage exchanges between the different cultures of the participating countries. During the Nation Night, each delegation is entitled to have a booth to present themselves, in a fair atmosphere. Delegations are free to bring any material for presenting themselves over the booth. The Nation Night is set to be on the June 23, in the Hotel Bourbon from 18:00hrs to 21:00hrs.

Important information: it will not be possible to bring food, animals or plants during this nation Night. On the other hand, you will be able to come with crafts, culture and floklore of your country.

Finally, Nations who so wish will be able to go on stage to present a typical dance of their country. If nations want to take part in this animation, please report to the LOC (service to delegations) and provide music/video in MP3/MP4 format by naming the file "nalmeofcountry.songtitle.MP3/MP4"





The Accreditation Center will be located in the Hotel Bourbon

The accreditation center will be open all day long on June 18th and 19th June All delegations, coming either with their own means of transport or with the LOC's means of transport from the airport, are expected to arrive directly to be accredited:

Hotel Bourbon

An identification document must be presented to get the accreditations At the Accreditation Center, the Head of Delegation must be present. He/she can be accompanied by a coach or by an additional adult. No other member of the delegation shall be admitted to the accreditation room.

At accreditation, the following *documents will be checked:

1.Valid ID/passport: The passport (or ID card) bearing family name, first name, photograph, nationality and date of birth for each member of the delegation. Please note that copies or scans of the ID/passports will not be accepted 2.Proof of payment: proof of payment of the balance including any bank charges. To help the ISF to correctly process your payment, please complete the "payment overview" form and send it to the ISF by e-mail prior to your arrival on the event.

3.ISF Consent Form: the use of image and anti-doping consent form of each participant, signed by the competitor's parent or legal guardian if he/she is a minor.4.ISF School Certificate: the ISF School Certificate form signed by the legitimate School Sport Entity, confirming that all athletes are full time students in school since the beginning of the school year.

5. Insurance: the document certifying that the delegation is covered by an insurance. At a minimum the insurance is to cover civil liability, material damage and medical costs.

Participation Fee

ISF Levy

An additional ISF levy per delegation member must be paid together with the balance of the participation fee.

Appendix

COVID-19 Information

LOC information regarding the COVID measure

According to the guidelines of the federal health agency – ANVISA.

Rules for those arriving by plane

- Vaccinated travelers must present proof of vaccination:

- Travelers not fully vaccinated, as long as Brazilians and foreigners residing in Brazilian territory, those with a health condition that contraindicates vaccination (attested by a medical report), those not eligible for vaccination due to age or coming from countries with low vaccination coverage: must present to the airline, before boarding, the document proving they have performed a test for Covid-19, with negative or non-detectable results, of the antigen or RT-PCR laboratory test type, performed one day before the moment of boarding.

- Foreigners who are not fully vaccinated will not be allowed to enter the country (with some exceptions).

Information about the Vaccination Certificate:

- must be printed or in electronic media; (vouchers that are exclusively in QR-CODE format will not be accepted);

- must contain the traveler's name, the vaccine manufacturer's or trade name, the batch number(s) of the dose(s) applied and the date(s) of the dose(s) application;

- vaccines approved by Anvisa, by the World Health Organization (WHO) or by the authority of the country in which the traveler was immunized are valid;

- the application of the single dose or the last dose of the primary vaccination scheme must have occurred at least 14 days before the date of departure.

* The documents issued abroad must be presented in Portuguese, Spanish or English.
